
Distinguished Innovator

- **Budget**: Up to DKK 6 million in total
- Grant period: 3 years
- Potential grants awarded per year: 10
- Next deadline: 9 March 2022

EVALUATION CRITERIA and WEIGHT

- 1. Applicant and team
- 2. Novelty, feasibility
- 3. Commerical potential

The main Applicant needs to show a proven track record within innovation (previously established patents and spin-outs)



Funding for commercial activities - what does this mean?

Any relevant commercial activities – costs for consultants, patents etc

Can a project apply if there is a company formed around the same project/idea?

No, if a company is already formed the Foundation will consider the project to have passed the proof-of-concept stage

Is the application confidential?

Yes, everything except the popular abstract

Are academic research projects from incubator development programs also eligible?

Yes, as long as no company has been formed around the project
